2008 has been a hectic and exciting year for EMILY's List. We have worked with EMILY's List MPs to achieve a land mark victory for Victorian women - the decriminalisation of abortion in that state. The long campaign's culmination coincided with 100 years of white women's suffrage in Victoria. We also celebrate the achievements of EMILY's List candidates, in the Northern Territory, Western Australia, New South Wales and the Australian Capital Territory. We commend the Rudd Labor Government's action on social justice, equity and climate change, and hope that they continue with this in the future.

Our priorities for 2009 will include the further implementation of the Strategic Plan. Key projects include the expansion of the Sisters Doing it for Themselves project to increase the participation of indigenous women in public life. We aim to keep the pressure up on the ALP to ensure that women are well represented at the highest levels keeping the pressure up on Affirmative Action. We will implement a project to Foster the Next Generation of women leaders, and continue to advocate for a national paid maternity leave system. The Queensland State Government is scheduled to go to the polls early in 2009 and we wish Premier Anna Bligh and her Labor team the very best for the campaign.

The EMILY's List National Office will shut down for the festive season from Monday 22nd December. Staff will be back on 5th of January, energized for another year of elections, advocacy and events. CEDAW OPTIONAL PROTOCOL

Australia begun the process of formally acceding to the Optional Protocol to the Convention for the Elimination of Discrimination Against Women. This will provide Australian women with access to a dispute resolution mechanism at the highest level. EMILY's List commends the Rudd Labor Government for taking this important step.

RWANDAN WOMEN MAJORITY IN NEW PARLIAMENT

On the 15-18 September, women won 45 out of the 80 seats available, making the incoming parliament the first in the world to have women in the majority - 56.2 percent. This outstanding result effectively rebuts outmoded ideas about gender equity and development.

“We need governments to address in policy—and promote in their dialogue with citizens—the need to assist individuals and communities in their efforts to overcome barriers to participation. We need governments that recognize that a person’s social vulnerability can increase exponentially when they are disadvantaged on more than one front. Abortion Law Reform *In Victoria*

EMILY's List congratulates the Victorian Parliament on the passage of the Abortion Law Reform Bill. We commend the Parliament for harmonising current medical practice, community attitudes and the law. We thank Premier John Brumby, Health Minister Daniel Andrews and Minister for Women's Affairs Maxine Morand for their strong leadership and integrity throughout the contentious debate.

EMILY's List thanks all of the women, and men, from across the political spectrum, who have worked tirelessly in the community and in the Parliament to make the decriminalisation of abortion a reality. This is an historic moment for the recognition of women's rights in Victoria.

We would especially like to thank our pro-choice MPs for their principled stand; their commitment to just and equitable outcomes for all Victorian women, their determination to see the Bill through, their dedication in defeating numerous regressive amendments, and their courage in the face of contemptible tactics from some quarters. We are grateful for their diligence; their thoughtful, measured and articulate contributions to the debate; and their unswerving respect for women and women's right.

EMILY's List believes that this landmark legislation represents a vital shift in the way that our society respects women's ability to make sound decisions about their bodies and their lives. This legislation will mean that women in all areas of Victoria will be able to access safe, legal terminations free from persecution; and medical practitioners will be able to provide vital reproductive health services to women free from harassment.

It is our firm belief that the strong and increasing representation of women in the Parliament has made reform to Victoria's abortion laws possible. Women MPs advocating for the women's reproductive rights put decriminalisation on the agenda and were instrumental at every stage of Abortion Law Reform Bills development. We are especially grateful to Candy Broad MLC for her bravery in putting forward the Private Member's Bill last year, which set the scene for referral to the Victorian Law Reform Commission, and galvanised the Parliamentary process.

EMILY's List thanks all of those organisations and individuals who worked so productively together to bring about abortion law reform. We would particularly like to acknowledge former Premier and National Co-Convenor of EMILY's Joan Kirner for her inspirational leadership on this issue.

Draft Report on *Paid Parental Leave*

EMILY's List has welcomed the Productivity Commissions' recommendation of 18 weeks of leave for new mothers and calls on the Rudd Labor Government to introduce paid maternity leave in the next Federal Budget.

The provision of paid maternity leave is integral to fair and equitable workplaces and we believe that the model put forward in the draft report is a positive one. We were particularly pleased to see that the recommendations are well above the minimum standards suggested by the ILO. EMILY's List was also pleased with the Commission's attention to the realities of working women's lives, through the inclusion of part time, casual, contract and self-employed workers in the paid maternity leave proposal. We commend the Commission for acknowledging the diversity of contemporary Australian families by proposing leave entitlements for both heterosexual and same-sex couples with new babies.

The model suggested by the Commission would help workers balance the competing demands of work and family life; promote lifelong workforce attachment for women and redress, to some extent, the barriers they face at work. Normalising employees caring responsibilities, has been, and will continue to be an important process in changing the culture of work to better respond to the needs of an increasingly diverse workforce.

The proposed model is not a perfect system. In particular, EMILY's List would like to see employer top-ups over the tax-payer funded minimum wage rate incorporated into the paid parental leave scheme.

EMILY's List made a supplementary submission to the Commission in response to the draft report calling for the recommendations to be implemented. We hope to see the Rudd Government implement a publicly funded system which facilitates, supports and values women's contributions in the workplace and to the workforce as soon as possible.

Review of the *Sex Discrimination Act*

2008 saw the first review of the effectiveness of the Sex Discrimination Act in its history by the Senate Standing Committee on Legal and Constitutional Affairs. While EMILY's List welcomed this long overdue inquiry into the effectiveness of the Commonwealth Sex Discrimination Act, we urge the Committee to consider a more wide-ranging and dynamic consultation on this issue.

The short time frame limited the breadth of the inquiry and impacted on the length, depth and number of submissions received. Given this is the first review of this legislation in almost 15 years, there is a substantial scope for review and consultations around the true effectiveness of and potential improvements to the *Commonwealth Sex Discrimination Act 1984*.

As other organisations have made substantive submissions, the goal of EMILY's Lists submission was defined as flagging three

areas that we believe to be of particular concern. Our focus was on:

1. We believe there must be impetus for employers and other organisations to proactively address all forms of discrimination in their workplaces and in their service delivery.
2. Sexual harassment remains an area in which more work is needed to address gender equity.
3. Finally, we believe that discrimination on the basis of sex remains prevalent in our society and affects all areas of women's lives, and in many instances gender discrimination is subtle. As such, any reforms must seek to redress systemic and indirect instances of discrimination as well as more direct examples.

The Senate Standing Committee on Legal and Constitutional Affairs released its report on 12 December and we look forward to examining the detail early in the new year.
